### **Overview**

# 3C Building Control is a strategic partnership between Cambridge City Council, Huntingdonshire District Council and South Cambridgeshire District Council Local Authority Building Control.

The 3C Building Control team comprises of technical support officers, professional building control surveyors and street naming and numbering and business support and business development. The team are professional, highly experienced, and greatly valued by partners and clients. The ethos of the shared service is to ensure that the councils shared expertise, remains robust and a high-quality service is provided to residents and our communities.

#### What does the service do?

#### **Grant Building Regulation approval**

- Most types of building work in the UK need to comply with a set of minimum standards known as Building Regulations.
- The work can be self-certified by a competent person registered with an approved certification body or work can be checked, inspected, and certified by a statutory building control body such as Local Authority Building Control.

# Deal with statutory issues relating to the Health and Safety of people in and around buildings

• Local authorities have the power to act in respect of buildings that are dangerous or dilapidated, require demolition or constitute a hazard to public health and safety.

#### Maintain statutory records relating to buildings

As part of the local land charges process and to assist the CON29
agreement with solicitors on land transactions the local authority is
required to maintain records in respect of the Building Control function
for a period of up to 16 years.


#### Undertake discretionary work relating to buildings

 The skills and abilities of Building Control professionals lend themselves to fee earning specialist work for internal, other public sector and private clients.



3C Building Control has gone through such a transformation throughout the year and the team has continued to provide a professional service, visiting sites for compliance whist still maintaining the safety of themselves and those around them to bolster the construction industry and ultimately the economy. Over the last year the team have adapted to working from home facilitated by digital technology and requisite equipment with the option to also work in house at various council offices. Procedures were reviewed to prompt effectiveness whilst operating both virtually and in person in keeping with the guidelines that are followed to protect the health and safety of the team. Not only have the team been able to continue delivering outstanding customer service, but they have also been able to maintain their service and support each other during the change in legislation that came with the new and updated Building Regulations (Approved Documents F, L, O and S) brought forward this June 22.

3C Building Control has completed its service review that was identified as an internal growth strategy. This included the TUPE of staff from other Councils to consolidate the street naming and numbering function within the 3CBC Shared Service as well as providing new opportunities to expand 3C's Technical Consultancy arm and Professional Surveying team. A new team structure was created to facilitate the identified future growth for the service following opportunities created by the advent of the Building Safety Regulator within the HSE.
